- **XVI. CONSENT AGENDA** Mrs. Elrod reported that the Consent Agenda was in order. Commissioner Maxey made a motion to approve, seconded by Commissioner Wallace. The motion carried 4-0.
  - 1. Consider recommendation from the Finance Department to approve the expansion of the DebtBook services/contract.
  - 2. Consider recommendation from the Purchasing Department to approve the purchase of one (1) current model 5000 lb Lift Forklift from Octane Forklifts, Inc., in the amount of \$30,888.00 + \$20,500.00 for clamp for the Rome-Floyd Recycling Center. This was budgeted at \$60,000.00 and came in \$8,612.00 under budget.
  - 3. Consider recommendation from the Purchasing Department to approve the purchase of one (1) e GPS 20TL Base Rover or Equal from e GPS Solutions, Inc. in the amount of \$34,530.00 for the Engineering Department. This was budgeted at \$36,000.00 in the Water Account and came in under budget.

1. Consider recommendation from Purchasing to approve the purchase of two (2) 2022 Ford F-150 Super Crew Cab XL Pickup 4x4 or equal from Prater Ford in the amount of \$37,015.00 each for the Public Works Department.

These were budgeted in the 2017 SPLOST and were over budget by \$6,030.00. Savings from the Jetter Trailer will be transferred to make up the budget difference. — Mr. McCord presented the request for approval to the Commission with a delivery date of 54-86 days. Commissioner Wallace made a motion to approve, seconded by Commissioner Maxey. The motion carried 4-0.

- 2. Consider recommendation from Purchasing to approve the purchase of one (1) Ford F-150 Extended Cab Pickup 4x4 or equal from Prater Ford in the amount of \$31,195.00 for the Public Works Department. This was budgeted in the 2017 SPLOST at \$32,000.00. The remaining \$810.00 will go toward any upfitting charges the department may incur. Mr. McCord presented the request for approval to the Commission with a delivery date of 22-26 weeks. Commissioner Maxey made a motion to approve, seconded by Commissioner Wallace. The motion carried 4-0.
- 3. Consider recommendation from Purchasing to approve the purchase of one (1) Ford F-750XL with Grapple Knuckle Boom & Bed or equal from Environmental Products Group in the amount of \$164,885.00 for the Public Works Department. This was budgeted in the 2017 SPLOST at \$175,000.00 and came in under budget by \$10,115.00. Mr. McCord presented the request for approval to the Commission. Commissioner Maxey made a motion to approve, seconded by Commissioner Wallace. Commissioner Wallace asked what the delivery date would be, Mr. McCord stated it would be November 2022. The motion carried 4-0.
- 4. Consider recommendation from the Floyd County Attorney to approve a consent order between the State Election Board of the State of Georgia and Floyd County Board of Elections and Robert Brady. Ms. Harman presented the request to approve the Consent Order.

Ms. Harman: "Thank you Mr. Chairman. For your consideration this evening, I've brought before the Commission, a Consent Order which I have been involved in negotiations with the Attorney General's office concerning SEB action 2020-00194 which is the case that resulted when the Floyd County Elections Board self-reported an undercount of the initial vote tally for the 2020 general election. That undercount was discovered during the course of the self-proving audit conducted state-wide. The agenda item mentions Mr. Brady, the Consent Order that I've brought to the Commission has nothing to do with Mr. Brady, he is an additional party to the same case, but his charges before the State Elections Board are being dealt with completely separately, this Consent Order has nothing to do with those charges. I am not privy to the status of those charges he's represented by his own counsel and I don't know the status of those charges. This Consent Order deals only with a single finding of fault on behalf of the Attorney General's office, as a result of its investigation into that initial undercount; that finding of fault is that the Elections Board was found to have failed to request from Mr. Brady a reconciliation of each of the scanner machines used in Early Voting and

during the general election. Which, if it had been conducted by Mr. Brady, and requested by the Board, might have – and again this is just looking back with 20/20 vision at 2020 – but it might have enabled the Board to learn at an earlier point of the undercount and enabled to take corrective action. Nothing in the consent order, nor the investigative findings, indicates any intentional wrongdoing or misconduct on behalf of any member of the Board of Elections, it all focuses on this process of reconciliation requesting that review by the Board of Elections; again, and I think I reported back early on in 2021 as to my investigation, the investigation conducted by the Secretary of State's Investigator at the time, the State Elections Board's investigation, and now the Attorney General's investigation, all are consistent in finding that the Board of Elections engaged in no wrongdoing. The question of how the undercount actually came to be is one that leaves some issues unaddressed. The first issue being, when we had a voter who crumped her ballot and jammed a scanner in this room, in the Admin during early voting, for some reason, which has not been explained to me and I don't think that anyone has been able to discern, the two memory cards located inside that machine at that time as of that jammed ballot, would no longer communicate with each other, so the ballots from the first ballot cast in early voting, through the time of the jammed ballot, could not be extracted from those two memory cards as would be the normal course of events. When Mr. Brady found out that those memory cards would no longer communicate, the machine at that point was replaced with another scanner and ready and available for that purpose. So from jammed ballot voter forwards, all votes were included in the tally, then we had to deal with ballots number one through the ballot just before the jam. At the direction of the Secretary of State's office, those ballots were all rescanned in the server room on a high-speed scanner. The second issue, for which I do not have an explanation and the investigation has not found one is, for some reason, about half of the ballots from that morning were included in the final tally of votes, and about half were not. Files simply didn't migrate into the final tally. Again, there has been no finding of any intentional wrongdoing, in fact, if you take those votes as a whole and apply the same percentages that you would expect if you simply randomly pulled out a handful of ballots from that machine, about the same number of votes went for Republican candidates, about the same number of votes went for Democratic candidates. In other words, there's no indication that there was a pattern of pulling out any particular votes for those that were migrated and those that were not; but ultimately, the number of charges related to conduct on behalf of Mr. Brady, related to a number of processes that might have corrected that situation and were not followed at the time. This consent order that I bring to you tonight, again reflects, and I would say, from the time that this process began to date that potential fine, and this is not restitution it's a fine, has been greatly reduced by the Attorney General's office and I think that's reflective of their ultimate determination that there was an error in process during the course of the Board of Elections' consideration of the evidence before it at the time, that it initially certified the election results, but that there was no intentional wrongdoing at the time and the fine is de minimis and reflects that. So this consent order comes to you having already been approved by our new Board of Elections and

Registrations. After your approval, if you choose to do that this evening, it will appear on the State Elections Board's consent agenda at its next hearing date, and it does come to you with my recommendation. I'll be glad to answer any questions from the Commission if you have any issues, or would like some additional information."

Commissioner Wallace made a motion to approve, seconded by Commissioner Hancock. The motion carried 4-0.

- 5. Consider recommendation from Purchasing to proceed with the Parker Center Renovation by Multi-Craft Construction Services, LLC in the amount of \$71,690.00. This was budgeted in the 2017 SPLOST at \$75,000.00. and came in under budget by \$3,310.00. Mr. McCord presented the request to the Commission for approval. Commissioner Maxey made a motion to approve, seconded by Commissioner Hancock. The motion carried 4-0.
- 6. Consider recommendation from Rome-Floyd Parks & Recreation Authority to name the renovated skate park in honor of Bob Moore. The new name would be the Bob Moore Kick Flip Skate Park. Mr. McCord presented the request to the Commission for approval. Commissioner Wallace made a motion to approve, seconded by Commissioner Hancock. The motion carried 4-0.
- 7. Consider recommendation from Facilities to revise the Elections Capital Budget by \$28,170.00, Elections All Other by \$400.00, and Elections Supplies by \$350.00 to continue the move to the Health Department Building. Mr. McCord presented the request to the Commission for approval. Commissioner Maxey made a motion to approve, seconded by Commissioner Hancock. The motion carried 4-0.

### XIX. OTHER BUSINESS

Chair Bagby stated the Commission entered into Executive Session during Caucus to discuss the acquisition of property and personnel, no action was taken.

Commissioner Wallace announced the ribbon cutting for the Bob Moore Kick Flip Skate Park would be Monday and the public is invited to attend.
