## VIII. FIRST READING

Mr. Wood presented the three planning items for first reading.

- 1. File Z25-09-02, for the property at 4558 Martha Berry Hwy. (o Martha Berry Hwy. as listed on the Parcel Viewer), Rome, GA 30165, Floyd County Tax Parcel J10Y032, requests to rezone from Suburban Residential (S-R) to Community Commercial (C-C). Staff recommended denial. Should the Commission choose to approve, then staff recommends requiring Dark Sky compatible lighting to protect the two adjacent residential properties from light pollution. Planning Commission recommended denial without prejudice by a vote of 9-0.
- 2. File Z25-09-03, for the property at 0 Moran Lake Rd. (785 Moran Lake Rd. as listed on the Parcel Viewer), Rome, GA 30161, Floyd County Tax Parcel L13X088, requests to rezone from Suburban Residential (S-R) to Agricultural Residential (A-R). Staff recommended approval. Planning Commission recommended approval by a vote of 9-0.
- **3.** File Z25-09-04, for the property at 0 Burlington Rd., Rome, GA 30161, Floyd County Tax Parcels M11X064 and M11X065, requests to rezone from Suburban Residential (S-R) to Light Industrial (L-I). Staff recommended denial. If the commission decides to approve, staff recommends approval on the following conditions: (1) that the property remains vacant to all commercial/industrial

uses until brought up to code, (2) that a professionally produced redevelopment plan be submitted within 90 calendar days after approval of the rezoning or code enforcement actions will resume, (3) that there be no exterior storage of goods, products, or equipment, excluding the parking of delivery vehicles, (4) that the applicant maintains the existing mature trees along Burlington Road, (5) that exterior lighting be limited to dark sky lighting. Exterior illumination shall be shielded, downcast and of a luminosity designed to maintain the existing night sky darkness and to prevent light trespass onto adjacent properties. In order to obtain this objective, the following criteria shall be met: (a) all fixtures shall be full cut-off type fixtures, (b) light poles shall be no taller than 25-feet in height, (c) all light poles must be setback a minimum of 10-feet from any exterior property line (d) maximum foot-candles at the property line shall be 0.5. Planning Commission recommended approval with staff conditions (listed above) for parcel M11X064 and recommended denial of the request for parcel M11X065 by a vote of 9-0.

- 1. Consider request from Parks and Recreation to approve a contract with Chick-fil-a to advertise at The Rink at Ridge Ferry Park in the amount of \$8,500. This will be billed at the time of approval.
- 2. Consider request from Parks and Recreation to approve a contract with Coca-Cola to advertise at The Rink at Ridge Ferry Park in the amount of \$8,500. This will be billed at the time of approval.
- 3. Consider request from Parks and Recreation to approve a contract with Georgia Power to advertise at Chili Fest in the amount of \$1,500 and to advertise at the Rink at Ridge Ferry Park in the amount of \$8,500. The total contract is for \$10,000. This will be billed at the time of approval.
- 4. Consider request from Parks and Recreation to approve a contract with GNTC to advertise at The Rink at Ridge Ferry, in the amount of \$1,000. This will be billed at the time of approval.
- 5. Consider request from Parks and Recreation to approve a contract with Rome Athletic Club to advertise at The Rink at Ridge Ferry Park in the amount of \$500. This will be billed at the time of approval.
- **6.** Consider request from Parks and Recreation to approve a contract with Rome Area Volleyball to conduct volleyball leagues and games at the Thornton Center and the Anthony Center. This will be billed 30 days before the due date of January 1, 2026.
- 7. Consider request from Parks and Recreation to approve a contract with Courtesy Ford to advertise at The Rink at Ridge Ferry Park. This will be billed at the time of approval.
- **8.** Consider request from the Water Department to acquire a temporary water easement from the Board of Regents of the University System of Georgia on behalf of the University of Georgia for the Bells Ferry Road water line relocation.
- Onsider request from the Police Department to purchase an equipped 2019 Dodge Charger from Calhoun Police Department to replace a 2019 Dodge Charger, totaled in a previous auto accident, at a cost of \$12,500. Insurance settlement funds are expected to be paid to the County within the week. These funds will be used to purchase this vehicle.
- **10.** Consider request from Finance for approval of participation in national opioid settlement for eight opioid manufacturers.

11. Consider request from Parks and Recreation to approve a sponsorship contract with Academy Sports in the amount of \$7,500 per year. This is pending final legal review. There will need to be an increase to the budget for 2025 and then the 2026 amount will be included in the original budget.
