 - **b.** Move Status Mr. McDonald reported that the move to the new election Center is basically complete with the exception of unpacking and connecting the server. That connection is to happen this Friday by the Secretary of State's staff.
- VI. Election Supervisor Report Mr. McDonald reported that redistricting is complete with precinct cards for those whose districts changed to be sent out in the next two weeks. The ballot proofing is complete with all names, positions, and wording for the SPLOST and party questions verified. Paper ballots should be mailed to the election Center by this Friday. UOCAVA ballots, for those voting from overseas locations were approved by the Federal deadline of April 8. These are for folks in the military, working or otherwise stationed overseas. There was a recruiting meeting here on April 13 to sign up poll workers with a turnout of about 80. Training will commence this Wednesday at the Election Center. The election equipment preparation is underway with L& A testing to begin on the 25th. Much of the equipment needed software updates and servicing with new toner for the printers.
